2. The Quotationer should clearly mention the **BID AMOUNT** of offer in Figure and Words against the vehicle mentioned above separately for each vehicle. Quotations must be accompanied with **Bid Security (Earnest Money) of Rs. 2000/- (Rupees Two thousand)** against each of the vehicle No. ARC-2629, AR01-3523 and AR01-8510 and Rs. 1500/- (Rupees one thousand five hundred) against the vehicles No. AR01-3442 separately in the form of **Demand Draft/DCR** in favour of Superintendent of Police, Fire & Emergency Services, Itanagar to be drawn at SBI, Itanagar without which the quotation will stand automatically rejected.


