TERMS AND CONDITIONS

1. The Director General of Police, Arunachal Pradesh, Itanagar invites sealed tenders on plain paper from authorised agents/ dealers/firms for providing of AMC (Annual Maintenance Contract) for a period of one year from the date of purchase of order for various equipments/ items which are installed at CCTNS Datacenter at PHQ Itanagar, Arunachal Pradesh. The sealed tenders will be received upto 1100 hrs on **10/08/2018** and will be opened at 1130 hrs on the same day. The tenderers or their representatives may remain present at the time of opening of tenders. The tender value will be Rs 9, 03,148 Lacs (**Rupees Nine lakhs three thousand one hundred and forty eight**) approx. The tenders received after scheduled date & time will not be entertained.
2. All the tenders must be accompanied with Earnest Money of Rs. 18,063/- (Rupees Eighteen thousand sixty three) only. Tenders without the Earnest Money will be summarily rejected. The tenderers are required to pledge National Saving Certificate (NSC)/Kishan Vikash Patra (KVP) in the form of Earnest Money/Security Money in the name of the Head of Office i.e. AIGP (E) from which the work is being allotted to them. The tenderers within the state of Arunachal Pradesh should purchase the KVP/NSC from the Post Office located at Arunachal Pradesh. As per Govt. order No. DSS/ACCTTS/2/99-2000 dated 17/03/2011. The tenderers outside the state of Arunachal Pradesh may purchase the NSC/KVP from the Post Office located at their location/state, but the same must be pledged to AIGP (E) PHQ, Itanagar, Arunachal Pradesh.
3. The successful tenderers will have to enter into a "DEED OF AGREEMENT" stipulating the Terms and Conditions of the contract. Security deposit will be subject to forfeiture in case of non - fulfilment of any or all the Terms and Conditions of contract. Earnest Money of the successful tenderers will be forfeited to the Government in case of failure to furnish security money and execution of "DEED OF AGREEMENT".
4. The cost of the AMC will be paid in two instalments i.e. 50% advance payment at the start of the contract and remaining 50% after successful completion of the contract.
5. The letter of authority in respect of authorized distributors/Dealership and the catalogue/Literature must be furnished along with the tenders.
6. The tenders must also accompany with attested copy of GST Registration Certificate and valid trading license issued by the competent authority for the items tendered by them.
7. The tenderers should be financially sound and necessary documents to this affect may be submitted with the tender papers.
8. Tenders should be quoted in two bid system, Part-I technical bid and Part -II price bid and should be kept in separate sealed covers. Price should not be indicated in the technical bid. (Rate should be quoted in Indian currency).
 - a. Financial bids shall be opened only of those bidders who have been declared technically qualified by the Committee. The criteria for eligibility and qualifications is to be met by the bidders such as minimum level of experience, past performance, facilities and financial position etc.
9. Technical compliance statement should be enclosed along with the tender clearly specifying deviation, if any, for all specifications mentioned in the tender.

10. Tenders should be addressed to the undersigned by designation and not by name. The separate sealed envelope containing the tender should be subscribed as **"Tender for providing of AMC for a period of one year for various equipments/ items installed at CCTNS Datacenter, PHQ Itanagar Arunachal Pradesh"** and sent by Registered Post or put in the Tender Box kept in the office of the undersigned (Provisioning Branch) on any working day from 0930 hrs to 1600 hours.
11. Successful Tenderers have to start the maintenance contract w.e.f. the date of issue of firm order /deed of agreement.
12. The Director General of Police, Arunachal Pradesh, Itanagar reserves the right to reject the lowest or all or any of the tenders without assigning any reason thereof.
13. The Director General of police of Arunachal Pradesh, Itanagar shall have the right to ask the firms to demonstrate their service before the deed of agreement is accepted.
14. List of the equipments/ items proposed to be covered under the scope of AMC with their description, specification and requirement are enclosed herewith.
15. In case of any dispute, legal jurisdiction will be at Itanagar, Arunachal Pradesh.
16. In case of any bandh call at Itanagar on the last date of receipt/opening of tender, the tenders will be received upto next working day till 1100 hrs and will be opened on the same day.
