Tenders will be received up to 1100 hrs on 14/03/2018 which will be opened at 1130 hrs on the same day.

The tenderers or their representatives may remain present at the time of opening of tenders.

Inspector General of Police (E), Arunachal Pradesh, Itanagar payable at S.B.I. Itanagar on any working day from 0930 hrs to 1600 hrs w.e.f. 22/02/2018 to 13/03/2018. The tenderers downloading the documents from website are also required to submit a Bank Draft of Rs. 1000/- as tender fees.

TERMS AND CONDITIONS.

1. Director General of Police, Arunachal Pradesh, Itanagar invites sealed tenders on plain paper from manufacturers, authorised agents/dealers/suppliers of reputed firms for entering into contract for supply of following stitched Winter Jackets for Arunachal Pradesh Police ( Civil Police/ AAP BNs/IRBNs) during the year 2017-18. The sealed tenders will be received upto 1100 hrs on 14/03/2018 and will be opened at 1130 hrs on the same day. The tenderers or their representatives may remain present at the time of opening of tenders. The tender value will be Rs. 2.00 crores approx.



2. The tenders received after scheduled date & time will not be entertained.
3. All the tenders must be accompanied with Earnest Money of Rs. 4,00,000/- (Rupees four lakh ) only. Tenders without the Earnest Money will be summarily rejected. The tenderers are required to pledge National Saving Certificate (NSC)/Kishan Vikash Patra (KVP) in the form of Earnest Money/Security Money in the name of the Head of Office i.e. AIGP (E) from which the work is being allotted to them. The tenderers within the state of Arunachal Pradesh should purchase the KVP/NSC from the Post Office located at Arunachal Pradesh. As per Govt. order No. DSS/ACCTTS/2/99-2000 dated 17/03/2011. The tenderers outside the state of Arunachal Pradesh may purchase the NSC/KVP from the Post Office located at their location/state, but the same must be pledged to AIGP (E) PHQ, Itanagar, Arunachal Pradesh.
4. Successful tenderers will be required to deposit 5% of the total value of the articles to be supplied as performance security money within 10 days from the date of issue of letter of acceptance of tender. The successful tenderers will have to enter into a "DEED OF AGREEMENT" stipulating the Terms and Conditions of the contract. Security deposit will be subject to forfeiture in case of non - fulfilment of any or all the Terms and Conditions of contract. Earnest Money of the successful tenderers will be forfeited to the Government in case of failure to furnish security money and execution of "DEED OF AGREEMENT".
5. The letter of authority in respect of authorized distributors/Dealership must be furnished along with the tenders.
6. The tenders must accompany with attested copy of GST Registration Certificate. Tenders must also accompany with valid attested Trading license issued by the competent authority.
7. The tenderers should be financially sound and necessary documents to this affect may be submitted with the tender papers.
8. The tenderers must submit two samples of each category of stitched jackets i.e Camouflage and Khaki. Tenders without samples will not be entertained /accepted.

9. The specimen pattern/shade of camouflage cloth of Arunachal Pradesh Police is enclosed herewith. The tenderers may also see the sample of camouflage cloth at PHQ, Itanagar (Provisioning Branch).
10. Tenders should be quoted in two bid system, Part-I technical bid and Part -II price bid and should be kept in separate sealed covers. Price should not be indicated in the technical bid. (Rate should be quoted in Indian currency).
  - a. Financial bids shall be opened only of those bidders whose sample will be found technically qualified by the Committee. The criteria for eligibility and qualifications is to be met by the bidders such as minimum level of experience, past performance, facilities and financial position etc.
11. Rate should be quoted F.O.R. Central Store, PHQ, Itanagar, Arunachal Pradesh by road transport (freight paid) for all items/quantity. Rates quoted others than F.O.R Central Stores, PHQ, Itanagar shall not be accepted. No packing or forwarding charges will be allowed. The rate of GST (as applicable) may be charged/quoted by the tenderers and the amount be clearly mentioned in the price bid separately. The rate should be quoted both in figure and words clearly. Tenders must be legible and clear in all respect else the tenders shall be liable to be rejected.
12. Technical compliance statement should be enclosed along with the tender clearly specifying deviation, if any, for all specifications of items mentioned in the tender.
13. Delivery of the stores will have to be completed within 60 days from the date of issue of firm order. In case of failure to supply the items in time, violation of any provision of Deed of Agreement, the firm is liable to be blacklisted.
14. Any breakage or loss of any items enroute or in transit will be at the supplier's risk.
15. If any item is found damaged or otherwise unacceptable at the time of delivery/inspection, the suppliers will be required to remove the same from Central Store, PHQ, Itanagar, Arunachal Pradesh at their own cost within 15 days.
16. Payment will be made to the supplier directly on completion of supplies and on receipt of stores. Document/ Vouchers/R.R.S bill etc. routed through Bank will not be accepted.
17. Tenders should be addressed to the undersigned by designation and not by name. The separate sealed envelope containing the tender should be subscribed as "**Tender for supply of Stitched Winter Jackets for Arunachal Pradesh Police during the year 2017-2018** " and sent by Registered Post or put in the Tender Box kept in the office of the undersigned (Provisioning Branch) on any working day from 0930 hrs to 1600 hours.
18. Successful Tenderers have to supply the items within 60 days from the date of issue of firm order failing which 5% of the total value of the articles to be supplied will be forfeited and supply order cancelled.
19. Quantities mentioned are all in approximation and subject to variation as per actual availability of funds.
20. The jackets will be required in 4 (four) sizes i.e 38 cm, 40 cm, 42 cm and 44 cm. Size wise requirement of the jackets will be indicated in the supply order.
21. Tenders will remain valid up to 31-03-2019.
22. The Director General of Police, Arunachal Pradesh, Itanagar reserves the right to reject the lowest or all or any of the tenders without assigning any reason thereof.

23. The Director General of police of Arunachal Pradesh, Itanagar shall have the right to ask the firms to demonstrate their items before the items are accepted. The items not found as per specifications shall be rejected.
24. In case of any dispute, legal jurisdiction will be at Itanagar, Arunachal Pradesh.
