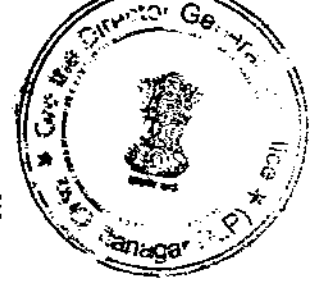

TERMS AND CONDITIONS.

1. Director General of Police, Arunachal Pradesh, Itanagar invite sealed tenders on plain papers from manufacturers/ authorised dealers/agents of reputed firms for entering into contract, for supply of various clothing items to Arunachal Pradesh Police for the year 2017-18. The sealed tenders will be received up to 1100 hrs on 15 /03/2018 and will be opened at 1130 hrs on the same day. Tenders received after scheduled date & time will not be entertained. The tenderer or their representatives may remain present at the time of the opening of the tender. The tender value will be Rs. 8.50 crores approx.
2. All the tenders must be accompanied with Earnest Money of Rs.17,00,000/- (Rupees seventeen lakhs) only. Tenders without the Earnest Money will be summarily rejected. The tenderers are required to pledge National Saving Certificate (NSC)/Kishan Vikash Patra (KVP) in the form of Earnest Money/Security Money in the name of the Head of Office i.e. AIGP (E) from which the work is being allotted to them. The tenderers within the state of Arunachal Pradesh should purchase the KVP/NSC from the Post Office located at Arunachal Pradesh. As per Govt. order No. DSS/ACCTTS/2/99-2000 dated. 17/03/2011, the tenderers outside the state of Arunachal Pradesh may purchase the NSC/KVP from the Post Office located at their location/state, but the same must be pledged to AIGP (E) PHQ, Itanagar, Arunachal Pradesh.
3. The tenders must accompany with attested copy of GST Registration Certificate and valid trading license issued by the competent authority.
4. The letter of authority in respect of authorized distributors/Dealership must be furnished along with the tenders
5. The tenderers should be financially sound and necessary documents to this affect may be submitted with the tender papers.
6. Rate should be quoted F.O.R. Central Store, PHQ, Itanagar, Arunachal Pradesh by road transport freight paid) for all items/quantity. Rates quoted others than F.O.R Central Stores, PHQ, Itanagar shall not be accepted. No packing or forwarding charges will be allowed. The rate of GST (as applicable) may be charged/quoted by the tenderers and the amount be clearly mentioned for all items. The rate should be quoted in Indian currency both in figure and words clearly. Tenders must be legible and clear in all respect else the tenders shall be liable to be rejected.
7. All tenderers must submit their samples in duplicate of each item tendered by them of which one sample will be returned to the successful tenderers as counter sample duly approved by the Board.
8. Tenders accompanied with more than two varieties of samples and rates for each item shall not be entertained. Once the sample is approved no change of shade, pattern or quality specifications or alternative offer will be entertained.
9. Tenders should be addressed to the undersigned by designation and not by name. The sealed envelope containing the tender should be subscribed as **"Tender for supply of clothing items for Arunachal Pradesh Police for the year 2017-18** and be sent by Registered Post. The local tenderers may, however, submit the tenders to the undersigned during office hours. Tenders received after scheduled date & time will not be accepted/entertained.

10. Successful tenderers will be required to deposit 5% of the total value of the articles to be supplied as security money within 10 days from the date of issue of letter of acceptance of tender. The successful tenderers will have to enter into a "DEED OF AGREEMENT" stipulating the Terms and Conditions of the contract. Security deposit will be subject to forfeiture in case of non-fulfillment of any or all the Terms and Conditions of contract. Earnest Money of the successful tenderers will be forfeited to the Government in case of failure to furnish security money and execution of "DEED OF AGREEMENT".
11. Successful tenderers have to supply the items within 60 days from the date of issue of firm order failing which 5% of the total value of the articles to be supplied will be forfeited and supply order cancelled. The stores supplied must be of the same specifications, weight and quality as per the tendered samples. Samples to be submitted must be in conformity to the quality/size/measurement/ weight as specified in the list of articles for supply at serial 18 below.
12. Any breakages or loss of any items enroute or in transit will be at the supplier's risk.
13. If any item is found damaged or otherwise unacceptable at the time of delivery/inspection, the suppliers will be required to remove the same from Central Store, PHQ, Itanagar Arunachal Pradesh at their own cost within 15 days. The equivalent replacement of approved quantity should be supplied within 15 days or the equivalent value in terms of money will be deducted.
14. Payment will be made to the supplier directly on completion of supplies and on receipt of stores. Document/Vouchers/R.R.S bill etc. routed through Bank will not be accepted.
15. Consignments shall be dispatched by the firm after payment of freight charges at source. Freight to pay consignment will not be accepted.
16. Tenderers may note that all unapproved samples submitted by them are returnable and should be collected by the tenderers within one month from the date of intimation from this office failing which the samples will be forfeited to the Government.
17. The Director General of Police, Arunachal Pradesh, Itanagar reserves the right to reject the lowest or all or any of the tenders with-out assigning any reason thereof.
18. Name of the items with their specification and approximate requirement are enclosed herewith (Annexure – A).
19. Quantities mentioned in the enclosure are all approximation and subject to variation as per actual availability of funds.
20. Tenders will remain valid up to 31-3-2019
21. In case of any dispute, legal jurisdiction will be at Itanagar, Arunachal Pradesh.
22. In case of any bandh call at Itanagar on the date of receipt/ opening of tender, the tenders will be received till next working day and opened on the same day.
